Heritage Update

Brandenburg, Kentucky–As we enter 2017, I wish to present you with image of resilience as our Heritage Update for January; as you are no doubt aware, the political cretins currently in charge of the city government of Louisville, Kentucky, orchestrated a pointless and highly disrespectful removal of that city's long-standing Confederate Monument. The men and friends of the Ben Hardin Helm Camp in the Bluegrass State worked very hard to save the monument, and have re-erected it in Brandenburg, Kentucky, along the banks of the Ohio River, plainly visible from Northern soil across said body of water. The Story of the Ladies Memorial Association of Augusta, Part III.

The corner stone of the monument was laid in April, 1875. Mrs. F. A. Timberlake, President of the Memorial Association, and the following officers laid the first bricks of the foundation: Mrs. A. G. Whitehead, Mrs. Edward F. Campfield, Mrs. DeS. Ford, Mrs. M. B. Moore, and Mrs. John Clark. It was indeed a novel sight to a large number of spectators to see the ladies, with delicate, ungloved hands, laying brick and handling the trowel, but it was a holy duty they performed—one most appropriate to the occasion and the subject—that of rearing a shaft of marble in memory of the brave men who fought and died for a cause they considered just.

To the invaluable aid of the press, the Ladies' Memorial Association owe much of their success.

In October, 1878, the monument was unveiled. The officers at that time were: President, Mrs. F. A. Timberlake (formerly Mrs. M. E. Walton); Secretary and Treasurer, Mrs. John T. Miller; Vice-Presidents, Mrs. J. M. Adams, *Mrs. E. M. Whitehead, Mrs. J. J. Cohen, Mrs. M. Campfield, Mrs. J. M. Clark, Mrs. M. A. Dantforth, Mrs. W. H. Barrett, Mrs. J. T. May, Mrs. M. B. Moore, Mrs. J. J. Thomas, Mrs. Bredenberg, Mrs.. Eastlebury.

The unveiling occurred in October, 1878. Upon both occasions there was a grand military and civic display, and addresses were delivered by distinguished orators. Upon the laying of the corner stone the address was delivered by Gen. Clement A. Evans, and upon the unveiling, it was delivered by Colonel Charles C. Jones, Jr. The monument stands seventy-six feet high. At the corner of the first section, twenty feet from the base, are heroic size marble statues of Generals R. E. Lee,, Stonewall Jackson, Thos. R. R. Cobb and W. H. T. Walker, representing the Confederate Cause, the State of Georgia and the County of Richmond, in which Augusta is situated. The second section contains bas reliefs of Confederate emblems, the coat of arms of the Confederacy and of the State of Georgia. The obelisk proper rises gracefully to its commanding height and is surmounted with an heroic size private Confederate soldier, standing "at rest."

The monument was unveiled in five and a half years after it was undertaken by the Association. It is justly considered one of the handsomest in the South, and stands to-day "the pride of Augusta and cynosure of every Confederate eye." The Association also contributed \$150.00 to the fund for the erection of a monument to the memory of Jefferson Davis.

The Battle of Aiken Re-Enactment will be coming up next month on the 25th and 26th of February. Cost: Adults: \$12; Ages 6 to 12: \$6; under age 5: Free The event is held at 1210 Powell Pond Road, Aiken, South Carolina, 29801, and is hosted by our friends in the Bee Camp # 1575 out of Aiken.

In the month of January, we honor the memory of Robert E. Lee, born on the 19^{\pm} of this month in the year 1807, and Thomas J. "Stonewall" Jackson, who was born on the 21^{\pm} in the year 1824.

We also mark the 19^{th} as a day of special significance in Georgia as the anniversary of the day when the people of this State, in convention assembled, acting in their absolutely sovereign capacity for themselves, withdrew all powers delegated to the old federal union by passing the Ordinance of Secession. We affirm their right to have done so, and their subsequent right to form a new partnership with other similarly situated seceded states, and to wage a just defensive war against an invasion. We reject any and all aspersions made against Georgia for having both seceded and waged war jointly together with the other Confederate States to defend herself from a government she had severed herself from, which had from her perspective clearly been usurped and subverted. To call secession "treason" merely begs or ducks the question, for if secession were rightful, and placed operationally into effect, then Georgia became by her own act a foreign State towards the remaining members of the Union, and it is an absurdity to speak of foreign states or foreign citizens committing treason against a government they have no longer any allegiance toward. Secession severed that allegiance, as each State rightfully had primal claim to the fealty of its own citizens. This, of course, was denied by the Lincoln government, and this, regardless of how one attempts to muddy the waters, is the constitutional question over which the contest of the 1860s was waged.
