Editor's Note: Below is the continuation of a series of articles on Georgia military units in which Richmond County men served during the War Between the States. Companies D and F of the 12th Georgia Battalion consisted of men from Richmond County.

# 12<sup>th</sup> Georgia Fights at the Third Battle of Winchester

By late summer 1864, the 12<sup>th</sup> Georgia Battalion, serving under Gordon with Early forces in the Shenandoah Valley began parrying with forces under Gen. Philip Sheridan whom Grant had placed in command of all the Federal forces in the Valley on August 3rd. Sheridan was initially cautious fearing a disaster might affect Lincoln's chances for reelection. The armies skirmished briefly at Guard Hill, Summit Point, Smithfield Crossing and Berryville. On September 19th, with Early having dispersed his forces, Sheridan attacked him at Winchester. The battle lasted from dawn to dusk, with Early consolidating his forces and maintaining a stiff resistance. However, by the end of the day, Sheridan's vastly superior numbers overwhelmed the Confederates, and they retreated to Fisher's Hill. The 12th Georgia Battalion sustained many casualties in this battle, including their acting commander, Capt. J.W. Anderson, who was wounded and captured.

On September 6<sup>th</sup>, Company C was ordered from Savannah to rejoin the 12th Georgia Battalion in Virginia which they did at Fisher's Hill. Prior to their transfer, these men were disheartened and disillusioned with a number of desertions occurring as Sherman's Army was moving freely through their home area around Stone Mountain.

### **Edgefield Judge Belinda Carpenter Speaks** on Southern Heroine, Lucinda Horn

During the February camp meeting, Mrs. Belinda Carpenter, an Edgefield County judge, UDC member, and re-enactor with the 19th SC Infantry spoke to the Camp on the Southern heroine, Lucinda Horn. Mrs. Horn, or "Aunt Cindy" as she was called, was the wife of Cornelius "Neil" Horn. They lived in a rented home near Kirksey in Edgefield County prior to the War and made pipes. When Neil and their son, William joined Company K. 14<sup>th</sup> SC Infantry in November 1861, Lucinda decided to accompany them to the front. While traveling with the Army of Northern Virginia in McGowan's Brigade, Lucinda prepared meals, mended and washed clothes, worked in the hospitals and earned her own money. She nursed her husband when he was wounded at the Battle of Frayser's Farm in 1862 and her son when he was wounded at the Battle of Jones' Farm near Petersburg, Va. in 1864. When "Billy" was given a pass to go home, she returned to the Palmetto State. Neil served until the After the war, Lucinda surrender at Appomattox. attended reunions of Confederate veterans, whom she called "her boys" and was made an honorary member of the 14th SC. When she died in 1896, Confederate veterans placed a memorial marker on her grave in Chestnut Hill Cemetery in Saluda.

Judge Carpenter stated that the women of the South were strong, resourceful and resilient and noted with sadness that most young people do not know our history. She expressed concerned for our country's present situation and believes the same factors that motivated our Confederate ancestors in 1861 is equally valid today.

Following her compelling presentation, Mrs. Carpenter was presented a framed photograph of the Confederate Powder Works chimney by Cmdr. Udell.

During the meeting, there were two applications for membership which were approved by the Camp: Randy L. Allen who joins the camp on the record of his great great grandfather, Pvt. William Hogan who served in Company K, 1st Georgia Militia and Wesley B. Thomas who joins the camp on the record of his Confederate ancestor, Pvt Mark Merritt who served in the "Irvin County Cowboys", Company A, 61<sup>st</sup> Georgia Infantry.

Certificates of memberships were presented to Compatriots Billy Belger and Tommy Chappells.

Cmdr. Udell announced that Compatriot Nick Posey will be assuming the role of Camp Adjutant and reported that the Camp presently has 92 members with a possible increase of 15 more. He stated Georgia Division Judge Advocate Dan Coleman has decided not to pursue a lawsuit against the Augusta Canal Authority for its removal of the battle flag sign on the Powder Works chimney. Udell reported that the 200<sup>th</sup> birthday celebration of Alexander Stephens willto be held on February 4th in Crawfordville and read a commendation by Gov. Deal recognizing such. He thanked all those who attended the Lee/Jackson Banquet and reported that 62 persons were attendance. Cmdr. Udell also thanked those who participated in the roadside clean up of Augusta West Parkway on January 14th. He announced the Georgia Division is considering a \$3 penalty for late dues.

Quartermaster Joe Winstead proclaimed he "wanted your money" for memorial pavers to be inscribed adjacent to the Confederate Monument. He read an advertisement detail-(Continued on page 3)



## NASCAR Nixes Pro Golfer's Lap in the "General Lee" at Phoenix Speedway

NASCAR recently nixed PGA golfer Bubba Watson from taking the initial lap in the dream car he recently

purchased for \$110,000, a replica of the "General Lee" from the Dukes of Hazzard television series, at the beginning of Sprint Cup Series at the Phoenix International Speedway to be held on March 4th. NASCAR stated the Confederate battle flag on the roof of the vehicle would offend some viewers. Watson, who is a close friend of NASCAR driver, Denny Hamlin, was invited to take the first lap by Phoenix race officials. Watson reportedly was extremely disappointed by the decision.

Ben Jones, former Georgia congressman and actor on the series, was troubled by decision and stated "...NASCAR has chosen to dishonor those Southerners who fought and died in that terrible conflict by caving to political correctness and the uninformed concerns of corporate sponsors. This action by NASCAR is a provocative and unnecessary over-reaction to a problem that doesn't exist. It is a disgraceful and gratuitous insult to a lot of very decent people."

NASCAR, under the leadership of Brian France, has continuously tried to distance itself from its Southern origins as it tries to be more "inclusive" and reach out to differing demographics. In the past, the SCV has conducted flyover messages at NASCAR events featuring the battle flag and asking NASCAR to remember its Southern roots.

#### **Forrest Statue Vandalized in Tennessee**

The equestrian statue of Lt. Gen. Nathan Bedford Forrest on I-65, south of Nashville, was recently vandalized. Bill Dorris, who owns the statue, states over \$6,000 in damages were incurred and that the statue has been vandalized repeatedly since it was erected in 1995. Nashville Metro Police are investigating the crime.

### Remembering our Irish-Celtic Confederate Heritage

#### 150 YEARS AGO: Battle of Shiloh, Tennessee

6-7 March 1862: Battle of Elkhorn Tavern (Pea Ridge) Arkansas; CSA Gens. Ben McCulloch and Gen. James McIntosh are killed.

8 March 1862: The CSS *Virginia* destroys the USS *Cumberland* and the USS *Congress* killing 250 men.

9 March 1862: CSS *Virginia* and USS *Monitor* are engaged for four hours to a draw in Hampton Roads, Virginia.

14 March 1862: Confederate forces withdraw from New Madrid, Mo. opening the way for a Union attack on Island No. 10

15 March 1862: Gen. John Hunt Morgan begins four days of cavalry raids around Gallatin, Tennessee.

17 March 1862: Under heavy gunfire, CSS *Nashville* runs the blockade out of Beaufort, NC.

22 March 1862: The first ship built in England for the CSA, CSS *Florida*, sails from Liverpool bound for Nassau.

23 March 1862: Battle of Kernstown, Va. Gen. Stonewall Jackson's only tactical defeat and the first battle of his Shenandoah Valley Campaign

28 March 1862: Battle of Glorieta Pass, New Mexico ends Confederate advance

5 April 1862: Siege of Yorktown, Va. begins

Edisto Island, SC occupied by Federals

6-7 April 1862: Battle of Shiloh, Tenn. Gen. Albert Sidney Johnston killed on the first day; Confederates retreat on second day to Corinth, Miss.

7 April 1862: Island No. 10 falls after a long siege
