# Compatriot David M. Powell 1939-2015

Longtime Alexander Camp member, David Powell, went home to be with the Lord on Thursday, February 25<sup>th</sup>. David had been a member of the Alexander Camp for 22 years and both

an SCV and Georgia Division Life Member. A member of the Camp's Honor Guard, Compatriot Powell was a re-enactor with the 1st Georgia Infantry, the 5th Georgia Infantry and the 32nd Georgia Artillery. He assisted in the organization of the Honor Guard for the crew of the *H.L. Hunley* submarine in North Charleston and the Confederate re-enactors for the rededication of the Confederate Powder Works Chimney in 2010. As a camp member, Powell was involved in a number of projects namely the refurbishment of the Confederate Monument on Broad and the Confederate platform at Magnolia Cemetery. His greatest goal, however, was the completion of the refurbishment of the Chimney of which he was a major benefactor.

An Air Force and Navy veteran, David was a member of the Augusta Genealogical Society, past president of the Powell Family Reunion, and a member of numerous business and trade organizations. Knowledgeable in many subjects, he enjoyed fishing, hunting, golf, and traveling.

Prior to retiring, he was the owner and CEO of several businesses: Pleasant Heating and Air Conditioning, Columbia Custom Marble, Petersburg Learning Center and DMP Builders, Inc.

He is survived by his beloved wife, Marie, his daughter, Pamela P. Rudder, two grandsons and two great grandsons. He truly will be missed.

#### Last Camp Meeting

### Frances Cutting & Daphne Hopson Speaks on "The Day the War Stopped"

During the February 2015 meeting of the Alexander Camp, Ms. Frances Cutting and Ms. Daphne Hopson spoke on the topic, "The Day the War Stopped," when Confederate and Union combatants laid down their arms in St. Francisville, Louisiana to conduct a funeral service for a Yankee officer.

Ms. Cutting and Ms. Hopson are members of Gen. W.H.T. Walker UDC Chapter #2253 in Augusta, the Daughters of the American Revolution and the National Society of Colonial Dames

They began their presentation by showing a video; however, audio problems caused the women to discuss the events that led to a truce and the burial of the Union officer.

In March 1863, only two ships were able to pass the Confederate bastion of Port Hudson on the Mississippi: the USS Hartford, Admiral Farragut's flagship, and the USS Albatross. During the siege of Port Hudson, the two ships conducted raids and shelled several Confederate positions along the river including St. Francisville.

In June, the Union commander of the USS Albatross, Lt. Cmdr. John Hart of Schenectady, NY, suffering from delirium related to high fever, committed suicide. Knowing Hart was a Mason, his shipmates sent an ensign ashore to find the local Lodge and to request a Masonic burial for him. The ensign discovered that the senior Warden of the Lodge in St. Francisville was one of the Confederates that had been harassing the Yankee ships, Captain W. W. Leake, of Company C, 1st Louisiana Cavalry. Understanding Hart was a fellow Mason, Leake met with the Union officers and agreed to the funeral service at Grace Episcopal Church with burial in the church cemetery. Ironically, Grace Church was often a target for Union shelling.

On June 12<sup>th</sup>, a contingent of US Marines and Navy officers and sailors bore Hart's coffin up the steep bluff to the church where, in the presence of Confederate Masons, he was buried with full Masonic honors. It was a brief moment of peace and fellowship in a time of war.

Throughout his life, Capt. Leake continued to care for Hart's grave which received a headstone in 1956. Today, Hart's burial ceremony is re-enacted each June in St. Francisville.

Following their interesting presentation, Cmdr. Baxley gave each of the ladies a copy of a book on the Lee Chapel.

# Florida's Department of Veterans Affairs Omits Confederates from State's Veterans' Hall of Fame

**REPORT** Weterans Hall of Fame stating they "did not meet the criteria set forth by the Florida Veterans Hall of Fame Council, and

by applicable federal and state laws defining veteran status." The names of Confederate veterans, David Lang, Samuel Pasco and Edward A. Perry were omitted. Lang is known as the "father of the Florida National Guard", Pasco became a US Senator from Florida, and Perry became a Florida governor.

The program, which began in 2013, recognizes and honors military veterans who, through their works and lives, during and after their military service, have made significant contributions to the state. The Florida DVA must submit the names to the Florida Cabinet for inclusion into the Hall of Fame.

The SCV is calling for an investigation by the Florida Attorney General of the Florida DVA headed by Mike Pendergast for the delay in submitting the names and the omission of the Confederate veterans.

David McCallister, commander of the Judah P. Benjamin Camp, SCV, in Tampa, said he is ready to take legal action if necessary to insure the three Confederate veterans are included. The nominations were made last year and the names were to have been placed on a plaque in November. As a result, the delay has caused the entire 2014 class from entering the Hall of Fame for over three months thwarting attempts to honor aging World War II veterans while they still are alive.

Meanwhile the Florida NAACP and longtime Confederate heritage hater and columnist, Daniel Ruth, have expressed their opposition to the inclusion of the Confederate veterans in the Veterans Hall of Fame.

Compatriots are asked to contact the following individuals with the title of your correspondence being "Leave No Veteran Behind". VFW and American Legion members are requested to notify your fellow veterans of this situation.

# 150 YEARS AGO: The Battle of Bentonville, NC

13 March 1865: After much discussion, the Confederate Congress authorizes the enlistment of black soldiers

16 March 1865: Battle of Averasboro, NC: Hardee attempts to halt Union advance

18 March 1865: Confederate Congress adjourns for what will be its last session

19-21 March 1865: Battle of Bentonville, NC: Johnston's Army of Tennessee attempts to stop Sherman

22 March 1865: Union Gen. James Wilson raid on Selma, Ala. begins

25 March 1865: Petersburg Campaign: Gen. Gordon's troops capture Union Fort Stedman but a Federal counterattack recaptures the fort

26 March 1865: Federal siege of Mobile, Ala. begins

27 March 1865: Battle of Spanish Fort, Ala.

1 April 1865: Battle of Five Forks, Va.: Lee's line is outflanked southeast of Petersburg; Federals seized Southside Railroad

- 2 April 1865: Lee's line at Petersburg is broken, Gen. A.P. Hill is killed Battle of Fort Blakely, Ala.
- 3 April 1865: Richmond and Petersburg falls to Union forces, Lee retreats west

4 April 1865: Lee's starving army arrives at Amelia Courthouse and discover expected supplies have not arrived; the delay is fatal

5 April 1865: Lee's route south from Amelia C.H. is blocked by Union cavalry

**Right: The battle flag of the 40<sup>th</sup> Alabama Infantry:** At the Battle of Bentonville, NC, in March 1865, three color bearers were shot down carrying this flag which was issued to the unit in Dalton, Ga. in May 1864. Following the battle, a small group of men including the flag bearer, Hilliard O'Neal, became separated from the rest of the regiment for several days narrowly avoiding capture on a number of occasions. To avoid losing the colors, he removed the flag from its staff and wrapped it around his leg, wearing it underneath his clothing.
