## Georgia Division Announces Return of SCV License Plates

The Georgia Division recently announced that SCV license plates are now available in tag offices and urged all compatriots who have not done so to consider purchasing the plate. Governor Deal had ordered the SCV plate discontinued following the Charleston massacre and suggested removing its battle flag logo. However, the Georgia Division moved forward and reached an agreement with the Georgia Department of Transportation to save the time honored logo. In the process, the design with the faded Army of Tennessee battle flag in the background was eliminated, but the 120 year old SCV logo in its full color will be retained. The image of the statue of Gen. John B. Gordon at the Georgia state capitol will not be on the plate as previously reported

Georgia law has permitted a specialty license plate for the SCV for more than a decade with the proceeds being used by the Division to maintain monuments and to erect memorials and veteran grave markers. More than 3,500 Georgians have paid the additional fees to obtain the plate, and the demand has recently surged. Notwithstanding, a petition was begun this past summer by a left-leaning radical group, Better Georgia, which demanded removal of the SCV's logo from the plates.

The state of Virginia, under compliance of its Democratic governor, recently recalled all of its SCV license plates which featured the battle flag logo and reissued the plates without it. North Carolina's Governor McCrory threatened to do the same, but wisely dropped the matter.

### **Confederate Monuments to be Removed; Relocated**

Confederate memorial monuments in Florida, Maryland, Missouri and North Carolina were recently removed or will be relocated following decisions by politically correct officials reviewing all things "Confederate" following this past summer's racially tinged Charleston murders. It is quite apparent that the haters of our heritage, who initially stated they only wanted flags removed from public property, want our memorials honoring our soldiers and sailors eliminated as well.

The memorial monument and flag flown honoring Florida's last living Confederate veteran, "Uncle" Bill Lundy, will be removed from public property in Crestview, Florida and given to his descendants. The City of Gainesville, Florida recently voted to remove its Confederate soldiers' memorial monument, "Ol' Joe," which was erected by the UDC in 1904, to the grounds of a nearby historical museum. The City of Rockville, Maryland voted to remove their Confederate soldiers memorial monument from the Court House square to a local park, and Talbot County, MD commissioners are considering doing the same.

#### Last Camp Meeting

### Eddie Rogers of Aiken Speaks on the Life of Gen. Wade Hampton, III

During the September 2015 meeting of the Alexander Camp, Mr. Eddie Rogers, a broadcaster, USC Aiken graduate, and a member of the Joe Wheeler Camp in Aiken and WBTS reenactor for 15 years did a first person portrayal of Gen. Wade Hampton III.

Initially, Rogers brought greetings from the Aiken Camp and thanked all the veterans and those presently on active duty for their service. He presented awards to Cmdr. Baxley and Lt. Cmdr. Posey for their outstanding service to the camp. He also thanked the ladies for their attendance and stated the Confederacy would not have lasted long without the determined efforts of its women.

Mr. Rogers, dressed as the General, stated that Hampton's grandfather had served in the Revolutionary War and that his father had served in the War of 1812. Although, he was born in Charleston, his family moved to Millwood, a plantation near Columbia. Hampton liked fishing and hunting especially for bear. He became a planter and eventually a legislator who opposed the slave trade. In 1861, he organized and outfitted his own legion requesting 1,300 men--but obtaining 3,000-- training them at Camp Hampton near Millwood's racetrack. Rogers spoke of Hampton's exploits during the War particularly his five wounds which occurred at First Manassas, Seven Pines, and Gettysburg; the devastating death of his son, Preston; and the Beef Steak raid in 1864. He continued by discussing Hampton's post war political career as the leader of the "Red Shirts", Governor, Senator, and railroad commissioner.

Following his dramatic presentation, Rogers was presented a Powder Works fly ash bottle and a book on the Red Shirts by Cmdr. Baxley.

During the meeting, one new member was received into the camp, **Daniel West**, who joins on the record of his ancestor, Sgt. Daniel G. Kane of Company H, 53<sup>rd</sup> Alabama Partisan Rangers.

Cmdr. Baxley announced that a Magnolia Cemetery cleanup will be scheduled on. September 16<sup>th</sup>. He stated the Confederate Cross of Honor ceremony scheduled for September 26<sup>th</sup> at Fort Gordon has been cancelled due to the ludicrous demands of the Army officials. They required the Confederate re-enactors to enter and leave the base in their civilian clothing, that no Confederate battle flags be present at the ceremony, and forbid the singing of *Dixie*. Rather than submit to their "politically"

correct" demands, the Camp officers decided to cancel the ceremony and assist with the future placement of the Confederate Cross of Honor on the soldier's grave.

Adjutant Posey reported that the Camp has presently sold 22 memorial pavers and has 106 members including four members who have rejoined the camp. Eighty members have paid their Camp dues and 26 have not done so with the possibility that 3-5 will not. He stated the Camp has been extremely generous and has contributed over \$900 to the Georgia Division projects funds: Flags Across Georgia Fund: \$268, Heritage Offense Fund: \$527, Awareness Fund: \$80 and Disaster Fund: \$60.

### Virginia Flaggers Continue their Aggressive Strategy to Defend Confederate Heritage

During this past summer when Confederate heritage was attacked relentlessly by the forces of political correctness, the organization known never faltered and has continued their

as the Virginia Flaggers never faltered and has continued their aggressive strategy to defend the flag and Southern heritage.

When monuments were being vandalized all across the South, the group performed nightly guard watches to protect Richmond's monuments. One culprit was caught defacing the Davis monument and prosecuted.

When the city of Danville, Virginia removed the Third National flag from the grounds of the Sutherlin Mansion, the last capitol of the Confederacy, the Flaggers raised two battle flags and a Third National flag on private property in visible locations throughout the city.

On September 19<sup>th</sup>, when a radical group maligned the route of the UCI Road World Championship cyclist event on the opening day of the race because it traversed Monument Avenue in Richmond, the Flaggers hired a banner plane to fly over the city during the race featuring a battle flag and stating "Confederate Heroes Matter." Despite the fact that the pilot misspelled the word "heroes," the effort was highly successful.

Within the week, the Flaggers raised another battle flag in a highly visible location adjacent to I-65 in Sandston, Virginia on land leased by the group. The flag was entitled the "Kershaw Flag" in that it is located on land that was crossed by Kershaw's Brigade during the Battle of Savage Station.

On September 12<sup>th</sup>, the Texas Division, SCV passed a resolution affirming "their support and admiration" for the Flaggers stating they have successfully fulfilled the charge of Gen. Stephen D. Lee.

Boone County, Missouri officials recently removed "Confederate Rock" a memorial honoring its Confederate soldiers, from its location on the courthouse grounds 21 miles away to the Centralia Battlefield Historic Site.

The Dowd YMCA in Charlotte, NC recently told the SCV and the UDC they must remove a Confederate monument they erected



on its grounds in 1994. The memorial, located at the site of the defunct North Carolina Military Institute which later became a Confederate hospital and prison, features a battle flag and honors cadets who later served in the Confederate armed forces. Many soldiers who died at the hospital are buried behind the building.

The YMCA is planning a massive renovation of its facilities and sits on the grounds of the Institute which was modeled on West Point and razed in 1954. A spokesperson for the Y spoke volumes when she stated the monument "challenges our Y's commitment to welcome all."

Other Confederate memorial monuments under scrutiny include those in New Orleans, San Antonio, Texas, Portsmouth, Virginia, and Baltimore, Maryland.

Many states, including Georgia, South Carolina, North Carolina and Tennessee, have laws making it illegal to remove military monuments and memorials on public property. However, many states, like Florida, do not leaving Confederate memorials subject to the whims of Taliban-like officials.

The Civil War Preservation Trust, the nation's largest protector of battlefields, recently created a petition asking elected officials to prevent the hasty removal of monuments and memorials. Unfortunately, neither the American Legion nor other veterans groups have done the same.

The SCV and other Southern heritage organizations have met the foe in each of these instances to preserve these monuments in their respective locations. They won a recent victory in Norfolk, Virginia which decided to maintain its Confederate monument. Nonetheless, the recent purge of Confederate memorials makes it imperative that the SCV purchase its own land to place memorials and raise flags.

**Right: The gold and white battle flag of the 5<sup>th</sup> Georgia Cavalry**: The regiment was formed on January 20, 1863, from combining the 1st Battalion, Georgia Cavalry (made up of men from Liberty and McIntosh counties) and the 2nd Battalion (Bulloch, Chatham, Effingham, and Screven counties). Officially mustered in on May 17, 1863, they were sent to South Carolina where they fought at Johns Island, Charleston, and Green Pond. In May 1864, they were ordered to join Wheeler's Cavalry in the Army of Tennessee and fought throughout the Atlanta Campaign where they lost many men. The unit surrendered in Hillsboro, NC on April 26, 1865.
