Well, it seems the Federal boys are up to their old tricks again. That is, they are trying to get out of a long standing order or commitment since 1906 to treat Confederate veterans the same as Union ones, i.e. providing head stones for ALL American soldiers. I 'm not sure how long the VA has been providing headstones, but it is my understanding that it began in the late 1950's or earlier. Recently, they, the VA's general counsel, have decided to change how to interpret Federal law and this past July halted replacement of Confederate headstones. (They have two reasons for not replacing headstones and it is too lengthy for this column.) They are saying that if the stone was not originally provided by the Federal government, then it will not be provided. This is wrong. I'm sure this is the current group of politicians/administrators in Washington and the man who dictates policy via executive orders. (Last year, the VA changed the policy which stated a photo and a service record is required to obtain a headstone--no service record--no stone.) Now they are changing the interpretation again this year. I've had two requests denied because of no available record for the soldiers. A VA spokesman stated we need to lobby Congress for a change in the law or purchase them ourselves. (The bottom line is that we need to take care of the headstones at Magnolia Cemetery as

# Compatriot Gould B. Hagler Speaks on Georgia's Confederate Monuments

During the August meeting of the Alexander Camp, Mr. Gould B. Hagler, a fellow compatriot, Augusta native, and graduate of Wake Forest and Georgia State University, spoke of and gave a power point presentation on "Georgia's Confederate Monuments". Compatriot Hagler has photographed almost all of Georgia's Confederate monuments and a book on the subject is soon to be published by Mercer University Press. Hagler's presentation featured several unique monuments throughout the state and he stated he is more interested in the inscriptions on the monuments rather than their form. Hagler stated many inscriptions were taken from poems written by Confederate poets such as Fr. Abram Ryan, Henry Timrod, etc., but some also feature Bible verses. He stated most of the monuments were erected by women's organizations after the War. Collectively, the monuments mourn the dead conveying a deep sadness, praise the soldiers for their brave deeds and, more importantly, state the Confederate cause was honorable and their reason for their struggle was for freedom.

Following his informative presentation, Mr. Hagler was presented a framed photograph of the Confederate Powder Works chimney by Cmdr. Udell.

During the meeting, Commander Udell presented Certificates of Memberships to Lawrence Henderson and Randy Allen.

Cmdr. Udell thanked all those who participated in the cemetery cleanup on July 12th and August 4<sup>th</sup>. He stated the camp had received cards of appreciation from the Creech family and from last month's speaker, George W. Martin. Udell stated he had SCV Certificates of Appreciation to present to Compatriots Scritchfield and Bargeron for their efforts in flying the Confederate battle flag. He requested that the camp reimburse Compatriot Nick Posey for his travel to the SCV International Reunion in Murfreesboro in July, and the camp voted to approve the measure.

Adjutant Nick Posey stated the Camp has 109 members with nineteen SCV life members. He reminded the camp that they should receive SCV and Camp dues notices in the mail and those dues should be received prior to October 31<sup>st</sup> to avoid paying a late penalty. Posey also gave an update on the SCV Reunion which was held in

### Haywood County, NC Removes Compatriots' Flags from Confederate Memorial

For years, David Crook and several other compatriots had been placing small six inch Confederate flags in front of the

Confederate memorial at the courthouse square in Waynesville, North Carolina, for others had been placing small US flags in front of the other war memorials located there as well. Unfortunately, as long as Mr. Crook had been placing the flags, someone had begun to remove them on a daily basis. Notwithstanding, the US flags were allowed to remain at the other monuments. Compatriots began to wonder what was occurring until one discovered the county maintenance director removing the flags.

Earlier this year, local attorney Bob Clark, after seeing the flags, wrote the Haywood County commissioners asking them to stop the display of this "divisive symbol". The county manager, Marty Stamey discussed the issue informally with the commissioners and directed that county maintenance workers remove the Confederate flags and to monitor the monument daily to insure they were removed.

Sadly, the lackluster president of the NC Division of the UDC, Aileen Ezell, who has become a thorn in the side of many Tarheel compatriots, advised the compatriots to cease replacing the flags and to "let the matter die a natural death."

Earlier this month, compatriots held a protest at the Haywood County historic courthouse stated their flag is being discriminated against by the county. They even placed a full size Confederate flag on a pole adjacent to the monument.

Following the protest, county leaders allowed the flags to stay until a formal policy could be determined, but reversed their decision after a week and decided to remove all flags in front of all memorials.

# Remembering our Hispanic Confederate Heritage!

### 150 YEARS AGO: The Battles of Sharpsburg and Perryville

14 September 1862: Battle of South Mountain and Crampton's Gap, Md.

15 September 1862: Union garrison at Harper's Ferry surrender to Gen. "Stonewall Jackson; Gen. Lee gathers his forces at Sharpsburg, Md.

16 September 1862: Gen. Bragg's army surrounds 4,000 Federal troops at Munfordville, Kentucky; they surrender the next day

17 September 1862: The Battle of Sharpsburg (Antietam): Gen. Lee repels five Union assaults during the "bloodiest single day of the war"

18 September 1862: Wheeler's cavalry skirmish at Cave City, Kentucky Lee begins his withdrawal

19 September 1862: Battle of Iuka, Miss.; Gen. Sterling Price withdraws

23 September 1862: Lincoln issues his so called "Emancipation Proclamation"

24 September 1862: Confederate Congress adopts an official seal for the CSA

27 September 1862: CS Congress passes its second conscription act, enabling men ages 35-45 for the draft

1 October 1862: Gen. John Pemberton assigned command of the newly created Department of Mississippi and Louisiana

2-3 October 1862: Battle of Corinth, Miss.; Union Gen. Rosecrans successfully defends against Gens. Price and Van Dorn's attack

4 October 1862: Richard Hawes is inaugurated as Confederate governor of Kty.

8 October 1862: Battle of Perryville, Kentucky; Bragg's advance halted

**Right:** The Flag of the 1st Texas Infantry was carried into the Cornfield at Sharpsburg. After 20 minutes of savage fighting, 82.3% of the regiment was dead or wounded, the highest casualty rate suffered by any unit during the war. After seven color bearers were killed carrying the flag, it was found on the field after the battle, surrounded by dead Texans. Returned to Texas by the Federal Government in 1905, it is currently undergoing conservation.
