HATE GROUP TO PAY OVER 3 MILLION TO SETTLE LAWSUIT

The Southern Poverty Law Center (**SPLC**) announced that it would pay \$3.375 million to settle a lawsuit brought by a British anti-extremism group that was put on a list of "anti-Muslim extremists."

In a statement, the Alabama-based SPLC apologized to the Quilliam Foundation and its founder, Maajid Nawaz.

The settlement marked another black eye for the SPLC, which has repeatedly been accused of branding some conservative organizations as "hate groups." In March, the SPLC was forced to retract an article accusing reporters of enabling white supremacists and anti-Semites.

In other SPLC hate activity, more than two dozen "community members" asked the Albemarle (VA) County School Board at a recent meeting to amend the dress code to disallow Confederate symbols on clothing.

The school district has drafted a new code defined by the Southern Poverty Law Center. But for now at least board members decided to table the proposal for further consideration. This only means that the SLPC will amp up the pressure on the board.

SPLC: WHO THEY SAY THEY ARE; AND, WHAT THEY ACTUALLY DO

Who they say they are: "The Southern Poverty Law Center is an American nonprofit legal advocacy organization specializing in civil rights and public interest litigation."

SPLC's projects include the website Tolerance.org, which provides news on tolerance issues, education for children, guidebooks for activists, and resources for parents and teachers. Another product of Tolerance.org is the "10 Ways To Fight Hate on Campus: A Response Guide for College Activists" booklet

What they actually do: The SPLC is the organization most widely associated with tracking "hate" groups in the United States. It maintains lists of "hate groups," which it defines as groups that "... have beliefs or practices that attack or malign an entire class of people, typically for their immutable characteristics". It says that hate group activities may include speeches, marches, rallies, meetings, publishing, leafleting, and criminal acts such as violence—except for "criminal acts", isn't that what the 1st Ammendment guarantees us?

I and other critics of the SPLC say that it chooses its causes with funding and donations in mind. Their definition of "hate" is absurdly narrow and includes disagreements over political issues.

The SPLC occasionally responds by reviewing its actions and removing people or organizations from hate listings, such as that of Ben Carson. In 2018, *The Atlantic* wrote that while criticism of the SPLC had long existed, it had expanded recently to include "sympathetic observers and fellow researchers on hate groups" concerned about the organization "mixing its research and activist strains." *Graham, David A. (June 18, 2018).*

Analyst of political fringe movements Laird Wilcox has said the SPLC had taken an incautious approach to assigning the labels "hate group" and "extremist".

In 2010, a group of Republican politicians and conservative organizations criticized the SPLC in full-page advertisements in two Washington, D. C., newspapers for what they described as "character assassination" because the SPLC had listed the Family Research Council (FRC) as a hate group due to its "defaming of gays and lesbians". Signatories to the advertisement included 20 members of the House of Representatives, 3 senators, 4 governors, and 1 state attorney general In August 2012, a gunman entered the Washington, D.C. headquarters of the Family Research Council with the intent to kill its • staff

members and stuff Chick-fil-A sandwiches in their mouths. Corkins stated that he chose FRC as a target because it was listed as an anti-gay group on the SPLC's website.

- In October 2016, the SPLC published a list of "anti -Muslim extremists", including British activist Maajid Nawaz [see article on pg. 3].
- In 2002, the SPLC and the American Civil Liberties Union filed suit (*Glassroth v. Moore*) against Alabama Supreme Court Chief Justice Roy Moore for placing a display of the Ten Commandments in the rotunda of the Alabama Judicial Building. They subsequently destroyed him and the monument

According to a report from Tyler O'Neill at PJ Media, up to 60, mostly conservative organizations may sue the Southern Poverty Law Center for being included in the organization's list of so called "hate groups. Dozens of Christian and conservative groups have been similarly unfairly tarred by the SPLC as "hate groups," and it appears they will exact their own revenge on the organization.

In the past few decades, however, the SPLC has begun marking mainstream groups as "hate groups" on a par with the Ku Klux Klan. It has marked mainstream conservative groups as "hate groups" because they oppose same-sex marriage, and last year, 47 nonprofit leaders denounced the SPLC's "hate list" in an open letter to the media. The SPLC has admitted that its "hate group" list is based on "opinion," and that it intends to "destroy these groups completely." So it's been about politics all along.

Furthermore, many of the "hate groups" attacked by the SPLC do not encourage hate or violence, but merely disagree with the left-wing organization's political views. Many—ike the Family Research Council (FRC), the Ruth Institute, and Alliance Defending Freedom (ADF)—merely stand for marriage as between one man and one woman.

If you're worried that the SPLC doesn't have enough money to pay everyone for being defamed, don't be:

How much money does the SPLC have and where does it come from: The SPLC's already impressive endowment grew a staggering 35% in fiscal year 2017,_to more than \$432 million. Including operating funds, total assets topped \$477 million as of October 31, 2017. Total revenues and gains in fiscal 2017 exceeded \$180 million; more than triple the organization's expenses for the year, of just under \$60 million.

If you follow the SPLC at all, you take it for granted that the company will find a way to make money off the latest tragedy or controversy *du jour*. The SPLC

now has more than 300 full-time employees, many of them involved in marketing, public relations and fundraising and they are not about to let an opportunity to cash in pass them by. Feel the love. Donate early and often.

This brings us to the SPLC's latest fundraising scheme. Just as the company found ways to cash in on the Confederate flag controversy in 2015, and the tragic death of Heather Heyer in Charlottesville in 2017, and President Trump's referring to members of the violent and deadly Salvadoran gang MS-13, which has infiltrated many American cities and even smaller towns, as "animals." Considering the gang's lengthy record of brutal murders, decapitation, torture and rape, "animals" is one of the kinder terms that could be used to describe them.

The SPLC's growing team of PR professionals have come up with another classic fundraising scam: "*Tell President Trump To Stop Using Racist And Dehumanizing Rhetoric*," proclaims the page on the SPLC website. "This kind of rhetoric is unacceptable from anyone," they remind us, in a brief statement that completely omits any reference to MS-13 whatsoever.

How best to do this? A link to the White House website? No. Mr. Trump's personal Twitter handle? Nope. Maybe a useful email link to your senators or members of Congress? Not seeing any. Instead, the SPLC has conveniently provided a short online form where you can enter your name, location and email address. That's all you have to do.

What happens to your personal information when you hit the submit button? The site doesn't say. Maybe your name goes on a petition, though wouldn't you'd think they'd mention that?

Considering the hundreds of millions of tax-free donordollars the SPLC has generated over the past decades specifically through the use of "dehumanizing rhetoric," such as the ever-profitable "hate group" label, "domestic extremists" and "radical traditionalists" one has to wonder how the company avoids choking on its own hypocrisy.

Earlier this month the Southern Poverty Law Center released its IRS Form 990 tax return, noting that the company took in a staggering \$136,373,624 dollars in FY 2017 (leaving a paltry "non-profit" of \$76,589,303 for the year). Page 39 of the document breaks down what the company paid third-party telemarketers for the year. As usual, the amount paid to the telemarketers far exceeded the amount of money raised over the phone in the name of "fighting hate."

The SPLC paid four third-party telemarketing companies \$3,177,807 donor-dollars to raise only \$1,801,207 donor-dollars on its behalf. This leaves a shortfall of \$1,376,600.

As usual, this means that not only did every dime

raised from unsuspecting first-time donors go directly to the telemarketers, but thousands upon thousands of longtime donors got tapped to pick up the shortfall without ever realizing it.

How many people does it take to mop up a seven-digit deficit? Longtime donors. at a reasonable \$25 dollar donation, just over 55,000 suckers.

How can a private advocacy group afford this kind of horrific hemorrhaging year after year? It's quite simple. The SPLC takes a minor financial hit each year to get the names and addresses of thousands of proven first-time donors. They feed this information into their own huge, uber-efficient in-house fundraising machine and the future donations will roll in for years, if not decades, to come. As the old saying goes, "It takes money to make money."

SPLC: 47 Years of "Whites Only": In 1994, Dan Morse and Greg Jaffe, two reporters from the SPLC's hometown newspaper, the *Montgomery Advertiser*, published an 8-day exposé of the company. Amazingly, the reporters discovered that 23 years after opening its doors for business in 1971, there were no, (*zero*) minorities among the top leadership of the "nation's leading civil rights organization."

The headline for the lead article in the series reads: "Equal Treatment? No Blacks in Center's Leadership." "Inside, no blacks have held top management positions in the center's 23-year history, and some former employees say blacks are treated like second-class citizens."

The article noted that the handful of Black attorneys hired in the company's early days had all quit, some citing a "plantation mentality," and that the only African-American in any position of authority managed the mail room, where she had worked for the past 20-odd years.

Conclusion: The SPLC is as much or more a "hate group" and "racist" in its operations as any of the other organizations it tries to destroy.

Note: as your Editor, I try to keep my articles and material as brief as possible. I apologize for the length of this one, but I found it impossible to make it much shorter. It includes less than half of what I found, so I cut and slashed as much as I felt possible. There is so much inherently wrong and even evil about these people that I have only scratched the surface here.

- At 46, served as the first Secretary of State under George Washington.
- At 53, served as Vice President and was elected president of the American Philosophical Society.
- At 55, drafted the Kentucky Resolutions and became the active head of Republican Party.
- At 57, was elected the third president of the United States.
- At 60, obtained the Louisiana Purchase doubling the nation's size.
- At 61, was elected to a second term as President.
- At 65, retired to Monticello.
- At 80, helped President Monroe shape the Monroe Doctrine.
- At 81, almost single-handedly created the University of Virginia and served as its first president.
- At 83, died on the 50th anniversary of the Signing of the Declaration of Independence along with John Adams.

Thomas Jefferson knew because he himself studied the previous failed attempts at government. He understood actual history, the nature of God, His laws and the nature of man. That happens to be way more than what most understand today.
