

KNOW OUR CAMP OFFICERS

Sargent-at-Arms: As per the SCV Camp Manual, " "...is responsible for maintaining order and decorum in the meeting place. The Sergeant-at-Arms will also serve in parades as the color sergeant and attend memorial services, firing demonstrations and at other Camp events."

Brian Weber: Brian was born in the small town of Reserve, LA, which is between New Orleans and Baton Rouge. After graduating high school he married and began his working career, first at Kaiser Aluminum, a job that lasted 24 years, mostly as a Lab Tech. He realized early that he enjoyed working with and helping people. He attended classes at Tulane University, taking courses



at night/weekends, receiving his undergraduate degree in 1987. In 2000 he earned his MBA from Brenau University in Georgia.

He was blessed by having wonderful Christian parents and by being raised in the Deep South. Brian's feelings about the War for Southern Independence and how the South had been mistreated because of the war, have continued to be more solidified throughout his life as he has gained additional knowledge through research as well as involvement in patriotic organizations, such as the SCV.

Although he did not serve in the military, he holds our Veterans in very high esteem and has had the privilege of working with so many, in his position with Wackenhut Services. Not having served in the Military, as his father and 3 brothers had, is one of his greatest regrets in life. Brian's Great-Great Grandfather, Private Alexis Emile Weber, served in "the War" in Company A, 20th Louisiana Infantry, CSA.

Brian worked in his Dad's grocery store prior to working at Kaiser. When he left Kaiser, he joined Wackenhut at the Strategic Petroleum Reserve between New Orleans and Houston as a Labor Relations Manager. He then transferred with Wackenhut to the SRS site where he worked for 11 years before transferring again, this time to the Oak Ridge Tennessee site, in the same capacity. Brian retired in 2009, moved to Florida for 5 years but returned to North Augusta in 2014. In April of this year, he was asked to return to SRS in a part time consultant capacity.

While working at Kaiser, Brian was adversely affected by an Affirmative Action Plan that gave preferences to minority candidates and so he was bypassed for desirable positions. As a result, Brian filed a lawsuit in Federal Court challenging the AA plan. After winning in the Federal District Court as well as the Court of Appeals, the case was decided in 1979 in the U.S. Supreme Court, but not to his liking. He was the center of much nation-wide publicity. Information about the case can be found at USW vs Weber, 443 US 193 (1979).

Brian lives in North Augusta with his wonderful wife, Donna. Between them, they have children and grandchildren located across the South! Brian is a born -again Christian and was ordained as a Deacon in 2002. He and Donna attend Victory Baptist Church in North Augusta.


The authors of this latest revisionist lies were:

MYTHS vs. FACTS:

History books, the media, the school systems, etc. abound in falsehoods and inaccuracies of Confederate and Southern history. This fact sheet will help to clarify and dispel some of these rampant inaccuracies.

MYTH—The War of 1861 - 1865 was fought over slavery.

FACT—Terribly untrue. The North fought the war over money. Plain and simple. When the South started Secession, Lincoln was asked, "Why not let the South go in peace?" To which he replied, "I can't let them go. Who would pay for the government?" Sensing total financial ruin for the North, Lincoln waged war on the South. The South fought the War to repel Northern aggression and invasion.

MYTH—Only Southerners owned slaves.

FACT—Entirely untrue. Many Northern civilians owned slaves. Prior to, during, and even after the War Between the States (WBTS). Surprisingly, to many history-impaired individuals, most Union Generals and staff had slaves to serve them! U.S. Grant had slaves until 1859. When asked why he didn't free his slaves earlier, Grant stated, "Good help is so hard to come by these days."

Contrarily, Confederate General Robert E. Lee freed his slaves (which he never purchased—they were inherited) in 1862! Lee freed his slaves several years before the war was over, and considerably earlier than his Northern counterparts. And during the fierce early days of the war when the South was obliterating the Yankee armies!

MYTH—The Confederate Battle Flag was flown on slave ships.

FACT—None of the flags of the Confederacy or Southern Nation ever flew over a slave ship. Nor did the South own or operate any slaves ships. The English, the Dutch and the Portuguese brought slaves to this country, not the Southern Nation. But, even more monumental, it is also very important to know and understand that Federal, Yankee, Union ships brought slaves to America! These ships were from the New England states, and their hypocrisy is atrocious. These Federals were ones that ended up crying the

These Federals were ones that ended up crying the loudest about slavery. But without their ships, many of the slaves would have never arrived here. They made countless fortunes on the delivery of slaves as well as the products made from raw materials such as cotton and tobacco in the South.
