### **Yankee Prisons**

### Camp Chase; in

**Columbus Ohio;** By Michael Dann Hayes, in SCV publication "*Prison-Pens of the North*".



Located 4 miles west of Columbus, Ohio, this Union prison camp was named for Secretary of Treasury Salmon P. Chase—a former Governor of Ohio.

Used as a training camp for Union volunteers, the facility also became a prison for political and military prisoners from Kentucky and western Virginia. The early campaigns in the West saw the first large group of Confederate soldiers arrive, including enlisted men, officers, and a few of the



latter's black servants,

Camp discipline, early in the war, was lax. Confederate officers, upon their oath of honor, were allowed to leave the camp and enter Columbus, register in hotels, and receive gifts of money and food. During this time, the public paid for camp tours, and Camp Chase became a tourist attraction.

Soon after, the camp was transferred to Federal control and conditions became worse. The prisoners were housed in shoddy barracks with open latrines and above ground cisterns—the camp was located on low muddy ground. A brief smallpox outbreak led to US Sanitary Commission agents demanding reform. Camp conditions continued to grow harsh, as disease, filth, overcrowding, starvation, and exposure to the weather, especially cold winters, caused many deaths.

Originally built for 3,500 men, more than 7,000 eventually were imprisoned. The graves of more than 2,087 Confederate soldiers are located at

Camp Chase Confederate Cemetery, established in 1863.

Following the war, a Union officer and author of "The Story of Camp Chase," William H. Knauss, began marking the graves of Confederate soldiers. Because of his efforts, the first memorial services were held in 1896 and continue yearly.

### **Hooray for the Confederate Flag**

Al Sharpton is a darling of the national news media, primarily because he has a talent for making outrageous statements, and a complete lack of scruples. Keep this in mind, as in today's media-saturated world, nobody can be a successful demagogue without the cooperation of the "news" media.

A recent example is the attention given to Sharpton's demand that the Vice President apologize for visiting a hunting camp where somebody had hung a Confederate battle flag on a door of one of the buildings. The VP didn't go into that building and says he did not see the flag. Sharpton's apparent logic is that any person who finds himself in the vicinity of a Confederate battle flag has somehow insulted all African-Americans.

Flags are symbols, and the meaning of a symbol is subjective. I also recognize that some blacks see the Confederate flag as a symbol of racism. Morons like the Ku Klux Klan wave it about—along with the American flag. If I were black, I might not like it. If I were an American Indian, I might not like the Stars and Stripes, Et cetera.

There is no legal or constitutional protection for one's feelings. If something offends us, that's too bad. In a tolerant society, we would recognize that different symbols mean different things to different folks and not raise a stink about someone else's symbol.

To most Southerners, the Confederate battle flag symbolizes the bravery and devotion shown by our ancestors, who, put their bodies where their mouths were and died and bled for their cause. While slavery was one issue in the war, it was not the main one. Only 6% of white Southerners owned even one slave. The 1860 census shows about 3,500 free blacks, who owned slaves in the South.

The Confederate battle flag is a universal symbol of rebellion and independence. It appeared on the battlefields of World War II and on the Berlin Wall as it came down. I don't care whether Sharpton likes it or not. There is no law that says he must like it. There is no law that says anyone who displays the flag has to take it down or apologize to anyone.

You should also note that this flap about the Confederate flag is a recent happening. Till the 1950s, Americans of all colors showed respect for both flags. It was common at public concerts for bands to play both "Dixie" and the "Battle Hymn of the Republic." The flap over the flag originated with the NAACP.

The NAACP was having a hard time raising money. It had internal scandals. That is when the they decided to wage war on all things Confederate. It is just stupid for anyone to waste time arguing over a historic symbol. Period!

### A Letter from a Southern Woman, after the WBTS

"Am I still loyal to the Confederate flag? I love it with as much fervid zeal as in my young womanhood. And why should I not love it? I gave four years of tears and prayers for its success, four years of tireless toil to its vindication; while for three full years I was the victim of cruel and barbarous outrage at the hands of soldiers who invaded Southern homes under an alien flag.

When I recollect these wrongs perpetuated upon defenseless women and children my soul revolts at the reckless barbarity of Northern soldiers. While I suffered personal indignities from these "knights in blue," I am really glad that Northern women escaped the ravages of vandal hordes and know so nearly nothing of the horrors of war. Such scenes as we in the South were forced to witness blunt the finer sensibilities of women and put her out of her natural sphere.

Three days after the hospital in Sommerville, Tenn. was closed and the remaining sick and wounded Confederates had been removed, a raiding party of eighty Federal soldiers dashed into town and drove all the old men into the courthouse. Then they began a system of robbery, pillage, and plunder that beggars description. Wardrobes were smashed to pieces, trunks broken open, feather beds ripped apart and contents scattered—in fact, nothing of value escaped the vigilance of these barbarians. The principal sufferers were those who had been most helpful tending the wounded at the Hardwich Hotel Hospital.

While the war developed many phases of human depravity evidenced by the fiendish deeds of a barbarous soldiery, the reconstruction acts passed for our humiliation and the destruction of our social, industrial and commercial resources was the growing ignominy of despotism, and furnishes a painful contrast between a monarchy and a republic.

No, I shall never forget the Southern Cross and all the boys who marched under it. May that Almighty Providence who shielded you so signally in defense of the constitutional rights of the South in the cruel war, protect you and all the remnant of the brave Confederates and bring you at last to the Beautiful City."

#### **DID YOU KNOW?**

Members of our Camp 158 can be awarded the United Daughters of the Confederacy (UDC) Cross of Military Service. The Cross of Military Service is an outgrowth of the Southern Cross of Honor, and is presented to veterans of World War II, the Korean War, the Vietnam Conflict (*shown right*), and the Global War on Terror who are lineal blood descendants of Confederate military personnel.

To be eligible, you only need a copy of your DD 214, and your Confederate ancestor's name,

rank, and unit. I am offering to collect these at our next Camp meeting on October 8th.
